25 – GENERAL ORDER

BEFORE THE COURT ON 02 March 2016

Upon the application of the claimant lodged 22 February 2016 and at the Listing Conference, IT IS ORDERED THAT:

1. Where a party who has served a statement of intended evidence of a witness, does call the intended witness at the trial:
 - (a) That party may not, without leave of the court, lead evidence from that witness if the substance of the evidence is not included in the statement served; and
 - (b) Subject to the objections as to the admissibility of any evidence in a statement, the statement will stand as the evidence in chief of the witness.
 - (c) That party shall have the statement ready for tender at the trial together with copies for each other party, the witness and the court.
2. The Parties have leave to adduce expert evidence at the trial.
3. Within 28 days of the date of this order the Parties are to lodge and serve a statement of any expert witness the parties intend to call to give evidence disclosing the nature and substance of the expert evidence to be given by the expert witness and otherwise complying with Rule 72(2) of the Magistrates Court (Civil Proceedings) Rules 2005.
4. Not less than seven (7) days before the trial the parties are to lodge and serve written submissions.
5. The claim is listed for trial for two (2) days commencing at 10.00am on 16 & 17 August 2016 which dates shall be vacated if the hearing fee is not paid by the responsible party within seven (7) days of receiving advice of the same from the court.
6. If the trial dates are vacated by operation of Order 5 the matter should be relisted for a Listing Conference by the court.
