Dear Andrew Laughton,

We refer to the above Court Order where seizure of goods was affected by the Bunbury Bailiff's Office on the 7/08/2017 and note that to date you have made no financial effort to clear the Judgment Debt as directed by the above Court Order.

This leaves an outstanding debt of \$15,371.30, plus interest payable at 6% pa until final payment is received.

Be aware that if instructed by the Judgment Creditor to seize and sell property under seizure, the outstanding debt will increase by a thousand dollars or more.
